Nothing in the promises had told me that I'd become rich, famous, or infamous. Yet I mistakenly believed myself special. I believed I possessed special talents, unrealized of course, and that with enough faith and trust that these talents would mysteriously be noticed by some influential person or show business big shot and I'd be on easy street. Some great stroke of God's magic wand would have me

shining on the stage for all to envy—God's will for me. I'd at last feel as if I belonged; so many would be beholden to my gifted persona.

What I have discovered is that sobriety HARD WORK REQUIRING DISCIPLINE AND TOUGHNESS STREET is actually a lot of hard work requiring

jobs never really existed. If I were to have described such a job it would have simply amounted to me doing what I felt like, whenever I felt like it, answering to no one, and receiving a lot of money

that I'm only one of God's children, no more or less special. Making these discoveries has been the hardest lesson in maturity that I've had to accept. God has given me blessings beyond what I could have imagined in those early days, but he has not awarded my ego the fame and fortune it has unreasonably desired. God has carried me through difficulties in mysterious ways which I can only look back upon and explain as miracles, but he has not rendered me an artistic genius. I go to work each day and I do not love my job. It is not my dream job. Such

work and sobriety allows me to choose between being grateful for a sound, sober mind and body that can perform those labors or a sniveling malcontented child, blind to the gifts under the Christmas tree because he didn't get what he wanted.

Sobriety is simple. We are complicated often foolish at times of selfish immaturity. Wilson had written that: "Selfishnessself-centeredness! That, we think, is the root of our troubles." I must be one of the "some are sicker than others" because it has taken me over 37 years of sobriety to come to some truce with that assessment.

International: The anonymity-protected

digital version of the 25th World Service Meeting Final Report is available for download at www. aa.org. The 26th WSM will be held in 2020 in Rye Brook, New York. The committee recommended to the GSB that delegates to the 26th WSM be invited to attend the 10/31-11/02/2020 Board Weekend as guests of the US/Canada General Service Board.

Technology Communications Services (TCS):

Version 3.0 of the Meeting Guide App was released on September 5. It includes enhanced search capabilities, Daily Reflections, and a communications function.



Services:

Communication Services: Three major projects continue to be the focus of this assignment: website design; development of the AAWS app, which includes the meeting guide platform; and implementation of Google products.

Archives: So far this year Archives has responded to approximately 750 requests for information and accessioned 67 new items in both paper and digital.

CPC/Treatment: So far in 2019, 12 national exhibits have been coordinated, with 16 more to be completed.

Corrections: Following a positive response to a mailing to Corrections/Bridging the Gap/H&I Area Chairpersons noting the need for men to write to inmates through the CCS, there is no longer a waiting list.

Group Services: As liaison with Intergroup/ Central Offices the staff member on this assignment attended a local forum whose theme was unity and how A.A. entities can work better together.

Public Information: The P.I. assignment has been working with the Publishing department to develop draft "postcard style" service pieces with brief excerpted content about A.A.

Board Committees:

Finance: For the first six months of 2019 contributions of \$4,002,384 were \$185,912 (4.9%) greater than budgeted and \$185,912 greater than 2018. The committee expressed gratitude to the Fellowship for the continuing Seventh Tradition support.

Total revenue (gross profit from literature plus contributions) was \$8,935,712 or \$313,286 (3.6%) greater than budgeted and \$326,680 (3.8%) higher than 2018.

Publishing: The Big Book Alcoholics Anonymous is available in 71 languages, with 23 languages pending, and 16 new translations in progress, along with 5 revisions/retranslations. Twelve Steps and Twelve Traditions is available in 48 languages, with pending translations in Arabic and a revised Czech translation. Daily Reflections is available in 34 languages.

Work continues on the audiobook versions of the Big Book, "Twelve and Twelve" and Living Sober in English, French and Spanish. The Big Book and "Twelve and Twelve" ASL videos with updated closed captioning are in review. The Young People's video is now titled "Young and Sober in A.A.: From Drinking to Recovery," with subtitles in English, French and Spanish, and is in the final stages of production.

Work has started with a contractor in Mexico to create a Spanish audiobook version of



I brought to you all the good and all the bad of me. I didn't ruin anything, and I really feel that these two vears have been productive, and we are passing on Area 61 a little bit better than we found it. There is no way I can really tell you how this has changed me-really, I am a different and better person. I am so full of love for all of you, the other delegates I served with and Alcoholics Anonymous. So, for all of us, let's rotate on and continue to stay sober and spread the word.

Area 61 Assembly on Oct 19th Covered Much Ground



The Area 61 Assembly was held on Sat., October 19th at St. Kevin Parish Hall in Warwick. It was a full day of service reports, discussions, and decisions. A few highlights follow.

The 2020 Proposed Area 61 Budget was approved by the Assembly. Group contributions fund the standing committee services, Rhode Island's General Service participation, and overhead. Overhead is boring, but local service through the committees and connection to AA as a whole through our Delegate is exciting and indispensable.

Committee reports detailed how the budget noted above transfers to practice. Our Treatment & Accessibilities Committee is coordinating over 45 meetings per month at detoxes, hospitals, and recovery centers. The Corrections Committee is making it possible for AAs to bring meetings and literature to both the ACI and Wyatt Detention Center. The next long-timer's event, which gives a glimpse of our local history and culture, is in the works through the efforts of the Archives Committee. If you have visited aainri.com or received a weekly email about Area 61 events and service meetings, you have seen the fruits of the Information Services Committee. Cooperation with the Professional Community / Public Information Committee is disseminating information about what AA is and what it is not, as well as clear information about how the next person who needs us can find us. Have you heard that Grapevine, our meeting in print, is celebrating its 75th anniversary? The party is on and everyone is invited to join our Grapevine Committee on Nov. 11th at the Area Office, 7 p.m. There promises to be cake.

In addition to the standing service committees, Area 61 has two special committees which

are not funded by the Area 61 budget referenced above. They are event focused and supported mostly through registration fees. The Convention Committee will present the 44th Annual RI State Convention at Gurney's in Newport on March 20-22. This year's theme is 2020 A Vision for Us and with absolute certainty it will be a wonderful whirlwind of speakers, meetings, fellowship, good food, and fun. Young People in AA (YPAA) is the second active special committee, and this year

consciences, and alkathon schedules. The GSRs and district officers are busy with the service, recovery and fellowship of AA. We know that groups with a GSR are connected to AA as a whole and benefit because they have a voice, a vote, and easy access to shared experience. GSRs may well be the best-informed folks in town.

The Assembly held each fall is often referred to as the Elections Assembly. Most Areas throughout the US and Canada hold their elections for Delegate and other Area officers every two years at this general time. As is the norm, the 3rd Legacy Procedure was followed for our elections. Election results were: Steve L, Delegate; Alison H, Alternate Delegate; Tricia I, Chairperson; Joe H, Treasurer; and Anne M, Secretary.

Of course, if new officers will rotate in at the start of the year, the current crew of trusted servants will rotate on. Our delegate, Mary K., presented a moving farewell to the Assembly as part of her report. Mary shared her



gratitude for the opportunity to serve and the Assembly's confidence and support. Sentiments rebounded, as the Assembly offered a warm and enthusiastic ovation for Mary and her dedication, leadership, and service.

Two agenda items generated especially good discussion. The first was a proposed 2020 General Service Conference agenda item. The motion was to revise language in the AAWS pamphlet F3 Self-Support: Where Money & Spirituality Mix. Specifically, the recommendation from Area Committee was to add text that indicates that performance of service duties vary from area to area and groups should learn which entities provide the varying services and contribute accordingly. Also, the suggestion was to eliminate two contributions pie charts with suggested percentages. See inset. The motion passed and will be forwarded to the General Service Conference for consideration.

The second agenda item that created healthy debate was a discussion item about the process followed to add the Information Services
Committee (standing committee) and Young
People in AA Committee (special committee) to the Area 61 service structure. These committees were added through the Guidelines re-approval process in January 2019 and that methodology is in question. The discussion on this matter was tabled until our next Assembly on Jan.
25, 2020. Further exchange will no doubt be interesting.

A look back at the Assembly is incomplete without a review of the Pasta Challenge. It was a carb overload with thirteen different pasta dishes entered in the cook-off (13!). Three cheers for all the cooks. And congratulations to the winners: District 6 (Steve), District 5 (Jackie), and District 1 (April).



Final tidbits about the Assembly include a reminder to all trusted servants to "not check out yet," since our service term runs through December 31st. Further, the welcome mat is out as the Area 61 committees and districts elect new leadership in the coming weeks.

WHAT TO DO

For me, prayer and meditation are the key to living a life not dominated by fear and anxiety. It is not easy centering a life based on behaviors that I did not grow up practicing. My life was based on living up to expectations and goals developed in an adolescence engrossed in drinking alcohol.

If I did not perform according to the skewed



criteria I developed, I thought less of myself. This happened often so that my self image spiraled downward as I got older. Thoughts about my past lead to depression. Thinking about the future frequently caused anxiety. This was all founded on a belief system constructed on experiences of a drinking, pot smoking teenager.

This way of living caused me much misery. I needed to start approaching life differently in order to be at peace with myself. Prayer and meditation is the answer for me. Each morning I pray and then lie quietly breathing deeply for five to ten minutes. I try to listen to and follow the breathing. I repeat short prayers throughout the day, trying to direct myself to do the right thing. I have started to try and meditate, quiet still breathing, three times a day. This centers me and I do not experience fear and anxiety allowing me

a break, clearing my head, so that I can continue my day positively.
