#### <u>Alternate Delegate's Report</u> – Alison H. reported:

Addressed rotation of service positions as an important part of our fellowship – sharing responsibility for AA. Rotation helps forego ego, freeing us all to serve where we're needed. Rotation means we are temporary stewards, knowing that down the line somewhere else will share the responsibility. It's time for all of us to start thinking, talking and praying about what's next. This fall, Area and district committees will elect officers, to be effective January 2022. She has found access to resources so easy – General Service Manual, revised Area 61 guidelines, pamphlets on various positions, etc. We have a deep bench of members who have served in all positions. Encouraging all to reach out to them to ask questions and seek information, and to rotate in any direction other than out.

## <u>Archivist Report</u> – Don B. reported:

Currently working on a "Covid history" survey – distributed to Area and posted to the website, intended to capture what our groups did during the pandemic. Got the idea at NERAASA, and learned at NERF that many Areas are undertaking the same project. Coordinating with ISC to get more archival material and information on Area website – should be under "Archives Committee". He continues to go through boxes of cancelled checks, bank statements, etc., and has destroyed about half of the nine or ten boxes of that information. There are also audio recordings of the last two longtimers' panels on the Area website.

Convention chair is also working on similar pandemic history for Archives, and wonders if other committees would consider the same.

# Registrar's Report - Donna T. reported

On May 6 participated in a sharing session with GSO staff and records department regarding Fellowship Connection. Good session to learn about kinks in website and getting more technical support. Working on conforming district naming conventions that yielded twice the number of actual districts in the Area. Donna continues to reconcile as changes to system and information continue to evolve, and working through list of 69 groups and their "open" or "closed" status. Groups wishing to change their status should use the form on the Area website. Info will be forwarded to Area Registrar. DCMs have access to Fellowship Connection, and Donna will provide link to ensure access.

1. GSR for Kent County group spoke regarding proposed gender-neutral changes to literature. Referred to Conference background material and letter from GSO staff member regarding same. Identified concern regarding reference to other entities seeking to de-genderize literature, including, e.g., the New York Times and their changing practices and styles.

Kent County group conscience: Wants to make clear the group supports diversity and inclusion, but is concerned about Tradition implications of de-genderizing AA literature. Degenderization is direct conflict with Tradition 10. Proposing that GSO/Grapevine allow individual groups to decide on which preamble to use. Requesting actions to change preamble be reversed.

Motion: The changes to the preamble be reversed. No second to the motion.

Member asking for demographics of the group who brought forth the motion. Member was invited to reach out to the GSR directly. GSR took exception to the guestion.

2. Return in person for October Assembly.

Area Chair not sure whether within her purview, but prefers to leave to the group.

Motion: Area Assembly will meet in-person for hybrid meeting in October Motion seconded.

#### Discussion:

- Wi-fi is available at St. Kevin's.
- Important that we meet in person, even if in hybrid, because it will be election assembly. Otherwise, we will have to set up an entire election process, which is complicated.
